



When you're injured or ill

You may be able to get support when you have a condition related to your Qualifying Service.

What to do if you're injured or ill

1. Visit your health care provider

Visit your health care provider—this will most likely be your GP. They'll help you with your immediate health and wellbeing needs.

Discuss with your health care provider if your condition may be because of Qualifying Service.

2. Apply for treatment and support

If you think your condition is related to Qualifying Service you should apply for treatment and support from us.

1. Complete the application form.
2. Send the application form and any supporting information to us.

Which application form you need to use will depend on when you served.

Support during treatment and rehabilitation

If you served before 1 April 1974 or in Viet Nam

You may be able to get:

Weekly Income Compensation (<https://www.veteransaffairs.mil.nz/a-z/weekly-income-compensation/>)—if you can't work full time from injury or illness. This doesn't need to be because of service

If you served after 31 March 1974 on Qualifying Operational Service
